





## Health Equity Resources for Healthcare Workers

There are enormous challenges in health inequities and a lack of community resilience in areas that need it the most. Historically medically underserved communities – communities with lower income, rural communities, and communities of color – face obstacles in receiving health equity. In a <u>survey</u> of nearly 2,000 US resident physicians across various specialties, roughly 50% reported "having little to no training in understanding patients from different cultures" (HRSA, 2023). Trainings empowering healthcare workers to close health equity gaps can help mitigate health disparities.

## What is health equity and how do health disparities affect healthcare?

- According to the Centers for Disease Prevention (CDC), health equity is "the state in which everyone has a fair and just opportunity to attain their highest level of health", which requires addressing social determinants of health and health disparities.
   Moreover, racism must be recognized and addressed as a threat to public health.
